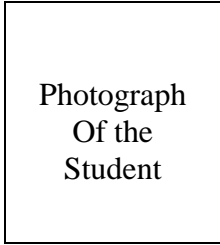

SIGNATURE OF ISSUING STAFF

NOTE: Student means a person who at the time of commencement of travel has reached his/her 12th but not his/her 26th birthday, and who is enrolled for a full time course for a session at an educational establishment. Students should not be employed for part time or full time nor should have any regular income from any source except stipend/scholarship granted to him.

‘**EDUCATIONAL ESTABLISHMENT**’ means a school, college or University offering full time educational, vocational or technical courses for a school year, recognised/aided by Central/State Government and/or affiliated to any or the Universities/ Boards and shall not include a commercial office industrial or military establishment or a hospital at which the student is serving an apprenticeship unless such apprenticeship is a part of the curriculum of the educational establishment at which the student is enrolled.

“**SCHOOL YEAR**” means a period 12 consecutive months including whatever interruptions, for vacations are normally granted by the educational establishment at which the student is enrolled.

This certificate is valid for issuance of tickets for thirty days from the date of issue by the head of the educational establishment.

It is necessary that this form is verified at the station of issue or at the nearest Sahara India Airlines office by the State Manager/Duty Officer of Sahara India Airlines in case an educational establishment is located at a place where Sahara India Airlines do not have an office but an approved travel agent is available the approved Travel Agent may verify this form and issue tickets.
